## Terms of the Competition

# 1. Glossary

## 1.1. Definition of Terms

For the purposes of this document, the following words and expressions used in these Terms of the Competition (hereinafter, the “Terms of the Competition”, “Terms”) shall have the meanings listed below:

<b>“Initiator”</b>	The Council of the Sirius Federal Territory
<b>“Client”</b>	Management Company of the Sirius Innovative Scientific and Technological Center JSC.
<b>“Application”</b>	<p>The information and documents submitted by the Applicant/Participant in order to enter the Competition.</p> <p>By submitting the Application, the Applicant/Participant consents to entering the Competition in the manner and under the conditions provided for in the Competition Documentation.</p>
<b>“Jury”</b>	<p>A collegial body created by the Operator in compliance with the Client’s recommendations for the purpose of reviewing the Participant Applications, selecting the Competition Finalists, and distributing the prizes among the Competition Finalists after Stage Two.</p> <p>The Jury includes representatives of the Client and Initiator, and authoritative and professional specialists in urban planning, architecture, and economics. The Jury members are appointed and act in their personal capacity and not as representatives of organizations, members (shareholders) of management bodies or employees of which they are. They must not follow, or request from any person, instructions on their decision-making within the competence of the Jury.</p>
<b>“Expert Council”</b>	<p>An advisory body of the Competition, formed by the Operator taking into account the Customer’s opinion.</p> <p>The Expert Council performs consultative and advisory functions within the framework of the Competition.</p>
<b>“Competition”</b>	An event to determine the best Competition Proposal developed by the Finalists via the organization of a competitive procedure under the conditions set out in the Competition Documentation.
<b>“Application Catalog”</b>	An Electronic archive of Applications for Participation which is prepared by the Operator and contains the Applications submitted by the Participants that have passed Qualification Selection.
<b>“Qualification Analysis”</b>	Analysis and evaluation of the composition and completeness of the Applications, and analysis of them for compliance with the qualified requirements of the Competition Documentation.
<b>“Qualification Selection”</b>	Selection of Applications by the Competition Operator, based on their conformity with the Application requirements presented.
<b>“Qualification Report”</b>	A document drawn up by the Competition Operator based on the results of Qualification analysis.
<b>“Comprehensive Evaluation”</b>	Evaluation of the Competition Proposals according to the criteria of compliance with the requirements of the Terms of Reference for the Finalists of the Competition, regulatory documents of the Russian Federation, and the Sirius Federal Territory.
<b>“Competition Documentation”</b>	<p>Documentation about the Competition, including:</p> <ul style="list-style-type: none"><li>● Invitation to Participate;</li><li>● Terms of the Competition;</li><li>● Terms of Reference and Initial data.</li></ul>

<b>“Competition Criteria”</b>	Criteria by which the Jury assess and compare Applications and Competition Proposals submitted by the Finalists. The Competition Criteria are given in Appendix 4 Terms of the Competition.
<b>“Competition Proposal”</b>	The result of the Finalist’s work on a master plan for the research and technology districts of the Sirius Federal Territory by the Finalists, in accordance with the Competition Documentation. The composition, contents, and requirements of the Competition Proposal, as well as the requirements for its layout, are defined in Appendix 3 Terms of the Competition.
<b>“Consortium”</b>	Association of two or more legal entities or individual entrepreneurs as a single Applicant/Participant.
<b>“Master Plan”</b>	A document defining economically justified architectural and urban planning features of the spatial development of scientific and technological districts of Sirius Federal Territory, containing a system of measures for implementing the proposed master plan of social, economic, environmental, and other areas of focus, developed on the basis of analysis of internal and external medium-term risks (6–10 years) or long-term (10–20 years) risks for developing the territory; takes into consideration the interests of various population groups and includes not only architectural and urban planning and infrastructure decisions, but also institutional measures and Proposals for the mechanisms to implement them. The document is prepared in accordance with the Terms of Reference of the Competition.
<b>“Operator”</b>	Agency for Strategic Development “CENTER”, LLC.
<b>“Winner”</b>	The Competition Finalist whose Competition Proposal, after being discussed by the Jury, has been ranked first in the Rating of Competition Proposals.
<b>“Applicant”</b>	Any legal entity, individual entrepreneur or Consortium of legal entities, individual entrepreneurs wishing to participate in the Competition.
<b>“General Terms of Reference”</b>	The Terms of Reference provided to Participants at the first stage of the Competition as part of the Invitation to participate.
<b>“Application Rating”</b>	Distribution of the Participants based on the total scores given to the Participants by the Jury members and the assignment of rating number in ascending order of the sum of scores from all Jury members, in which the Participant rated number 1 is the one with the highest score according to the Jury’s assessment.
<b>“Rating of Competition Proposals”</b>	Distribution of Finalists from 1st to 6th place. Based on the sum of the scores awarded by all members of the Jury, the Finalists shall be assigned numbers in the ascending order.
<b>“Technical Report”</b>	The result of a comprehensive evaluation of the Competition Proposals according to the criteria of compliance with the requirements of the Terms of Reference for the Finalists of the Competition, regulatory documents of the Russian Federation, and the Sirius Federal Territory.
<b>“Terms of Reference”</b>	A detailed description of the requirements imposed by the Operator on the Finalists’ Competition Proposals.
<b>“Terms of the Competition”</b>	The rules of the Competition contained in the Competition Documentation.
<b>“Participant”</b>	<p>The Applicant whose Application has passed the Qualification Selection and has been accepted for Jury review.</p> <p>Participation in the Competition is open to any legal entity, individual entrepreneur, or Consortium of legal entities or individual entrepreneurs, wishing to participate in the Competition and registered in the Russian Federation in compliance with the existing legislation of the Russian Federation.</p> <p>Foreign legal entities and individual entrepreneurs registered outside the Russian Federation can participate in the Competition only as part of a Consortium.</p>
<b>“Finalist”</b>	A Participant whose application is ranked from 1 to 6 in the Rating of Applications following discussion during the first meeting of the Jury.

## 2. General Provisions

### 2.1. Objective of the Competition

Selection of the best master plan for the research and technology districts of the Sirius Federal Territory, implementing a development scenario for the territory considering the potential and promising directions identified.

### 2.2. Subject of the Competition

Development of a master plan for the research and technology districts of the Sirius Federal Territory.

### 2.3. Roadmap and Timing of the Competition

The Competition has two stages. The Competition Roadmap is outlined in Appendix 1 hereto.

### 2.4. Powers of the Operator

The Operator carries out functions associated with the Competition, including:

- publishing and posting the notice of the Competition;
- publishing notices and notifications related to the Competition;
- receiving messages, information, and documents, including Applications and Competition Proposals, from the Applicants, Participants and Finalists;
- checking Applications and Competition Proposals for compliance with the Competition Proposal requirements of the Competition Documentation;
- consulting individual applicants to form international Consortium;
- creating and maintaining the Competition website;
- organization and conduct of preparatory and introductory activities;
- interaction with the members of the Jury and the Expert Council;
- preparation of materials for meetings of the Jury and the Expert Council, including the Catalog of registered participants of the first stage of the Competition;
- organization of meetings of the Jury and the Expert Council;
- explanation of the requirements of the Competition Documentation to the Applicants, Participants, Finalists, and Winner;
- management of Jury meetings;
- taking of minutes of Jury meetings;
- counting of votes at Jury meetings.

### 2.5. Powers and Principles of Activity of the Jury and the Expert Council

2.5.1. The powers of the Jury include:

- evaluation and comparison of Applications from Participants and the formation of the Application Rating selecting the six (6) Competition Finalists;
- evaluation and comparison of the Competition Proposals submitted by the Finalists, preparation of the Rating of Competition Proposals, and the selection of the Winner of the Competition;
- disqualification of Participants or Finalists.

The Jury shall be guided by the principles of professionalism, unbiased opinion, and objective judgment, as well as by the provisions of the Competition Documentation.

2.5.2. The powers of the Expert Council include:

- preliminary consideration and evaluation of the Competition Applications submitted by the Participants at the first stage of the Competition;
- formation of recommendations for consideration of Competition Applications for the Jury;
- preliminary consideration and evaluation of the Competition Proposals developed by the Finalists in the second stage of the Competition;
- formation of recommendations for consideration of the Competition Proposals developed by the Finalists in the second stage of the Competition for the Jury.

## 2.6. Applicable Law

Relations between the parties (Applicants, Participants, Finalists, Operator and Client) in connection with the Competition shall be governed by legislation of the Russian Federation.

It must be noted, however, that the provisions of Article 447 and Chapter 57 of the Civil Code of the Russian Federation shall not apply to the terms and conditions of the Competition.

## 2.7. Applicability of the Terms of the Competition

These Terms of the Competition and other provisions of the Competition Documentation are mandatory for all persons participating or involved in the Competition (without limitation: Applicants, Participants, Initiator, Operator, etc.).

A person wishing to participate in the Competition is considered to have agreed to the Terms of the Competition and other provisions of the Competition Documentation published at that time and is bound by these conditions and provisions from the moment of submitting an Application.

## 2.8. Amendments to the Terms of the Competition

2.8.1. The Operator has the right to decide on introducing amendments to the Terms of the Competition. Changing the subject of the Competition is not allowed.

2.8.2. Within 5 (five) working days from the date of the decision to amend the Terms of the Competition, but no later than 3 (three) working days before the deadline for receiving Applications, such amendments are published by the Operator on the Competition website and become mandatory for each Applicant/Participant of the Competition from that moment.

## 2.9. Competition Documentation:

The Competition Documentation includes the following sections, each of which is an integral part thereof:

- Section I: Invitation for participation (notification of the Competition);
- Section II: Terms of the Competition;
- Section III: Terms of Reference and Initial data.

## 2.10. Procedure for Publishing the Competition Documentation

2.10.1. Section I of the Competition Documentation (Invitation to Participate) shall be published on the Competition website in the public domain no earlier than February 23, 2025.

2.10.2. Section II of the Competition Documentation (Terms of the Competition) shall be published on the Competition website in the public domain no earlier than February 23, 2025.

2.10.3. Section III of the Competition Documentation (Terms of Reference for Finalists and Initial Data) is provided to the Finalists of the Competition after written confirmation of participation in the second stage of the Competition.

#### 2.11. Provision of Clarification

2.11.1. Any Applicant, Participant, or Finalist shall be entitled to request clarification on the Competition Documentation provisions from the Operator. Such request shall be sent in writing by mail or email to the address specified in the Terms of the Competition.

2.11.2. The Operator is obliged to respond to requests for clarification on the provisions of the Competition Documentation via digital means of communication within five (5) working days from the date of receipt of requests. Applicants' requests must be received no later than five (5) working days prior to the Application deadline.

2.11.3. The Operator is not obliged to respond to requests received after this date.

2.11.4. The delay in response shall not be considered a reason for deadline extension for Application or Competition Proposal submission.

#### 2.12. Settlement of Disputes

All disputes that may arise from the relations of the parties in connection with the Competition shall be considered in the Moscow Court of Arbitration.

#### 2.13. Language

The official languages of the Competition are Russian and English. Applications and Competition Proposals must be translated into both languages.

# 3. Competition Procedure

The Competition is held in two stages:

- Stage 1—acceptance of Applications and selection of Finalists based on portfolios, essays, and sketches. In the first stage, the Jury selects 6 (six) Finalists of the Competition based on a relevant portfolio, essay, and sketches.
- Stage 2—development of the Finalists' Proposals, Rating of Competition Proposals based on the assessment by the Jury, and selection of the Winner.

## 3.1. Application Submission

3.1.1. The form and structure of the Application are set out in Appendix 2 hereto. In order to submit an Application, it is necessary to register on the Competition website—siriusmasterplan.com.

3.1.2. Any legal entity, individual entrepreneur as an Individual applicant, or Consortium of legal entities, individual entrepreneurs wishing to participate in the Competition has the right to submit an application for participation.

3.1.3. Acceptance of Applications starts from the date of publication of the Invitation to participate and the Terms of the Competition on the Competition website and ends at 6 PM (Moscow time) on May 30, 2025.

3.1.4. Applicants may amend their Applications by sending notice, with the amended documents attached, no later than five (5) working days before the submission deadline.

## 3.2. Registration

3.2.1. Applicants shall be registered as Competition Participants based on the Applications submitted.

3.2.2. At the application acceptance stage, the Operator has the right to recommend that Applicants who do not meet the requirements for Competition Participants conclude an appropriate agreement with other applicants to form international Consortium.

3.2.3. The Operator has the right to refuse to register the Applicant as a Participant on the following grounds:

- the Application does not comply with the Operator's requirements;
- the same Applicant submitted more than one Application (including applications submitted as part of other Consortium);
- the Application has been submitted in violation of the deadline specified in Clause 3.1.2 hereof.

3.2.4. No later than ten (10) working days after Application submissions are closed, the Operator shall inform all Applicants of their registration as Participants or of registration denial, by sending them an email to the address specified in the Application, and provide the Jury and the Expert Council with the Catalog of Competition Applications that have been accepted for Qualification Selection.

3.2.5. Participants recognized by the Competition Operator as having an actual ability to influence the Competition result are not permitted to participate in the Qualification Selection.

## 3.3. Disclosure of information

Grounds for a possible conflict of interests:

If an Applicant/Participant (an official or employee of the Applicant/Participant), or in cases when the Applicant is a Consortium, any member of the Consortium (an official or employee of the member of the Consortium) is affiliated:

- with a member of the Jury or a member of the Expert Council, as well as to an individual who is a subordinate member of the Jury or a member of the Expert Council by official position;
- with an individual performing the functions of the Operator's sole executive body, or with an individual that is a member of the Operator's collective executive body (including co-executors, subcontractors and consultants that contribute to the Competition), or individual that is officially subordinated to such an individual (it must be noted that, for the purposes of this clause, an individual is not recognized as a subordinate if their job duties are limited to research, teaching, or creative work of any other kind), i.e. with an individual that, for the purposes of this clause, are deemed capable of influencing the Competition results, this Applicant/Participant may also be deemed capable of influencing the Competition results.

#### 3.4. Letter on Disclosure

3.4.1. If there is evidence that Clause 3.3 hereof applies to the Applicant/Participant, the Applicant/Participant shall provide the Operator with a Letter on Disclosure, depending on the time when the Clause becomes applicable:

- if the Clause becomes applicable at the time the Applicant submits the Application, the Letter on Disclosure shall be included in the Application;
- if the Clause becomes applicable after the Applicant submits the Application, the Letter on Disclosure shall be provided immediately after.

3.4.2. The Letter on Disclosure is drawn up in free form and must contain (the form of the Letter on Disclosure is specified in Appendix 7 to the Terms of the Competition):

- evidence that the Applicant/Participant may be deemed capable of influencing the results of the Competition in accordance with Clause 3.3, including an indication of the person with whom the Applicant/Participant is affiliated;
- the nature of the relationship that results or may result in the Applicant/Participant being recognized as an affiliate of the relevant person;
- any additional details of the relationship, which, in the Applicant's/Participant's opinion, may be useful for evaluating whether the Applicant/Participants may be truly capable for influencing the results of the Competition.

3.4.3. The Letter on Disclosure shall be included in the Catalog of Registered Competition Participants. If, in accordance with Clauses 3.3 and 3.4.1 hereof, providing a Letter of Disclosure is deemed mandatory for the Applicant/Participant, and their failure to do so shall constitute a clear and sufficient reason for disqualification.

#### 3.5. Consortium Participation in the Competition

##### 3.5.1. Consortium.

3.5.1.1. Legal entities and/or individual entrepreneurs wishing to participate in the Competition can unite in Consortium. Legal entities united in a Consortium shall submit a single Application on behalf of the entire Consortium, and shall be recognized for the purposes of the Competition as a single Applicant/Participant/Finalist. An Applicant wishing to participate in the Competition in the form of a Consortium provides a Declaration of Consortium, engagement of subcontractors and consultants as part of the Application

(the form of the Declaration of Consortium is contained in Appendix 5 to the Terms of the Competition).

3.5.1.2. A member of a Consortium cannot participate as part of another Consortium.

3.5.2. Consortium Leader.

3.5.2.1. Members of a Consortium must choose a Consortium Leader.

3.5.2.2. The Consortium leader can only be a legal entity or an individual entrepreneur registered in the territory of the Russian Federation.

3.5.2.3. The Consortium's portfolio must contain at least one project by the Consortium Leader.

3.5.2.4. For the purposes of the Competition, the Consortium Leader shall be recognized as a representative of the entire Consortium's interests in its interactions with the Operator.

3.5.2.5. For the purposes of further communication related to the Competition, the Consortium Leader shall provide information about itself, the personal information of its designated employee, their contact details, and information on subcontractors and consultants via the completion of a Declaration of Consortium.

### 3.6. Working Procedure of the Jury

3.6.1. There are two meetings of the Jury scheduled for the Competition:

- First Jury meeting: selection of the six (6) Finalists of the Competition. The Jury meeting is held in a hybrid format.
- Second Jury meeting: determination of the Winner. The Jury meeting is held in person.

3.6.2. If there is no quorum on the date of the Jury meeting, or if no decision is reached, the meeting may be rescheduled for another day (by decision of the Jury members present at the meeting or by absentee vote).

3.6.3. Jury meetings shall be attended by representatives of the Operator. The Jury is presided by the Chairman of the Jury.

The Operator's representatives shall be entitled to inform the Jury about the powers of the Jury, the objectives of the meeting, as well as about the procedural rules of the Jury, including the decision-making and voting procedures.

3.6.4. Chairman of the Jury:

3.6.4.1. The Chairman of the Jury is determined by the Operator in agreement with the Client.

3.6.4.2. Should the Chairman of the Jury be absent from the Jury meeting, their functions are fulfilled by the Deputy Chairman of the Jury.

3.6.4.3. Powers of the Chairman of the Jury:

- presiding over the meeting;
- accepting Jury members' Proposals regarding the inclusion of specific issues on the agenda;
- making Proposals for the agenda;
- formulating the issues on the agenda;
- monitoring compliance of the Jury's work practices.

3.6.5. Minutes of the meeting.

3.6.5.1. The Minutes of the Meeting shall reflect the agenda, the progress of the meeting, the decisions made, and the votes cast.

3.6.5.2. All members of the Jury present at the meeting shall sign the attendance sheet attached to the minutes.

3.6.5.3. The minutes of a Jury meeting shall be made in one (1) copy.

3.6.5.4. The minutes of the Jury meeting (extract from the minutes) containing the voting results shall be published on the Competition website within ten (10) working days from the date of the respective Jury meeting (without attaching an attendance sheet). The opinions of the members of the Jury, including the numbers of points awarded to each Participant and recorded on ballots, are not subject to disclosure or publication.

3.6.6. Voting and decision-making.

3.6.6.1. The Jury meeting shall be authorized to make decisions (shall have a quorum) if more than half of the Jury members are present.

3.6.7. Decision Making at Jury Meetings.

3.6.7.1. The Jury shall compile the Application Rating and Rating of Competition Proposals (unless it decides otherwise) as follows: each member of the Jury shall arrange the Participants/Finalists by place in the rating; the number of places must equal the number of Participants/Finalists. Based on the sum of the scores awarded by all members of the Jury, the Participants/Finalists shall be assigned numbers in the ascending order. The result of this arrangement shall be discussed by the Jury and accepted as final.

3.6.7.2. Voting is closed and shall be carried out by filling in secret ballots. The ranking of the Applications shall be formulated as the result of summing up the scores assigned to the Participants. The Rating of Competition Proposals shall be based on the sum of the scores awarded to the Finalists. In the event of the inability to attend a Jury meeting in person, a Jury member may submit their opinion in writing no later than 1 day prior to the Jury meeting.

3.6.7.3. The decision on the disqualification of a Participant shall be adopted by a quantitative vote on the principle of "one Jury member, one vote" by a simple majority of the total number of Jury members present at the meeting. Voting is open and shall be carried out by a show of hands.

3.7. Selection of Finalists

3.7.1. The decision on the selection of Finalists is made by the Jury taking into account the results of the Qualification Selection.

3.7.2. Participants recognized by the Operator as having an actual ability to influence the Competition result are not permitted to participate in the Qualification Selection.

3.7.3. No more than six (6) Participants allowed to participate in the Competition and awarded a place from 1 to 6 in the Application Rating are recognized as Finalists.

3.7.4. In the event that the Applications of several Participants score the same number of points at the end of the Jury meeting, the Jury shall vote again.

3.7.5. Should, according to the results of the repeat Jury vote, Applications submitted by several Participants be awarded an equal score, priority for inclusion into the list of Finalists shall be given based on the date and time of submission of the digital Applications via the Competition website <https://siriusmasterplan.com>.

3.7.6. The Competition Finalists must confirm further participation in the Competition by notifying the Operator within five (5) working days from the date of announcement of the list of the Finalists by email specified in Clause 2.14.2 of the Terms.

3.7.7. If by July 4, 2025 a Finalist is disqualified from participation in the Competition for any reason, the Participant whose Application was assigned next is recognized as a Finalist, except when the Jury has made a special decision

to choose a certain Participant as a replacement for the eliminated Finalist.

### 3.8. Provision of Terms of Reference

3.8.1. The final versions of the Terms of Reference for Finalists and the Initial Data are provided to the Finalists in the order established by clause 2.10.3 of these Conditions.

### 3.9. Procedure and Timing for Submission of Competition Proposals

3.9.1. Finalists must submit Competition Proposals to the Operator, corresponding to the Terms of Reference for Finalists, no later than 6 PM (Moscow time) on October 17, 2025.

3.9.2. Form of Competition Proposal Submission:

- in electronic form: through the Finalist's personal account on the Competition website and to the Competition's email address;
- in hard copy: the Proposal shall be sent to the address indicated in Clause 2.14.3 hereto.

3.9.3. If Competition Proposals are submitted by mail, courier delivery, or courier shipment, Competition Proposals are considered submitted on time if they are received by 6 PM midday, Moscow time, on October 31, 2025 at the corresponding delivery address indicated herein.

3.9.4. Participants shall be entitled to make changes to the composition of Competition Proposals at any time before the submission deadline by sending the Operator notice and attaching the documents to be amended.

### 3.10. Conditions for Use of Participants' and Finalists' Competition Proposals

3.10.1. Each Participant grants the Operator and the Customer of the Competition the right to use the works contained in the submitted Application, in the form contained in Appendix 8:

- the right to copy the Works;
- the right to put the Works on public display;
- the right to communicate about the Works on air;
- the right to communicate about the Works by cable;
- the right to translate the Works;
- the right to make the public aware of the Works.

3.10.2. Each Finalist is obliged to transfer to the Operator, along with the result of the work (Competition Proposals), the exclusive right to it as a result of intellectual activity in full. The relationship between the Finalist and the Operator shall be governed by the contract (agreement) concluded between them.

The Operator has the right to publish the Applications and Competition Proposals of the Applicants, Participants, and Finalists on the Competition website.

# 4. Grounds for Disqualification of Participants and Finalists

4.1. A Participant may be denied further participation in the Competition on the following grounds:

4.1.1. The structure and content of the Application do not meet the requirements of the Competition Documentation or Terms of Reference;

4.1.2. The same Participant has submitted more than one Application;

4.1.3. The Application has been submitted in violation of the established deadlines;

4.1.4. Affiliation;

4.1.5. Violation of the terms of the Declaration of Conformity.

4.2. The decision on the disqualification of a Participant is made by the Jury.

4.3. A Finalist may be denied further participation in the Competition on the following grounds:

4.3.1. The structure and content of the submitted Competition Proposal do not meet the requirements of the Competition Documentation and Terms of Reference;

4.3.2. The Competition Proposal was submitted in violation of the established deadlines;

4.3.3. Affiliation;

4.3.4. Violation of the terms of the Declaration of Conformity.

4.4. The decision on disqualification is made by the Jury.

4.5. The decision on disqualification is posted on the Competition website.

## 5. Winner Selection and Compilation of the Rating of Competition Proposals

5.1. The Jury shall consider the Competition Proposals submitted by the Finalists, and, taking into account the Competition Criteria set out in Appendices 3 and 4 to these Terms of the Competition, shall assign them number in the Rating of Competition Proposals.

5.2. Should two or more Competition Proposals receive an equal score, the Jury shall vote again to determine which of them is the best.

5.3. The Finalist whose Competition Proposal has been ranked first by the Jury shall be considered the Winner of the Competition.

5.4. The message about the compilation of the Rating of Competition Proposals shall be posted on the Competition website within three (3) working days from the date of the Jury's relevant decision. The opinions of the Jury members recorded on Ballots cannot be disclosed and published on the Competition website.

## 6. Rewards for the Winner and Finalists

6.1. The total Prize Fund of the Competition is thirty-four million (34,000,000) rubles 00 kopecks, including all applicable taxes and fees for the Finalists.

6.2. The Finalist whose Competition Proposal has been ranked first by the Jury shall be declared Winner of the Competition.

6.3. For the development of the Competition Proposal based on the contract concluded between the Operator and the Finalist, the Operator pays each Finalist four million (4,000,000) rubles 00 kopecks, including all applicable taxes and fees, and the reward amount includes:

6.3.1. Compensation in the amount of five hundred thousand (500,000) rubles, zero (00) kopeks (including all fees and taxes applicable to the Finalist), for transferring the exclusive rights to the Operator provided for by Articles 1229 and 1270 of the Civil Code of the Russian Federation, including the right to rework the project, to the Client.

6.3.2. Compensation for any expenses of the Finalist for the preparation and submission of the Competition Proposal in the amount of three million five hundred thousand (3,500,000) rubles, zero (00) kopecks, including all applicable taxes and fees for the Finalist.

6.4. Following a meeting of the Jury, the Operator accordance with the prize distribution:

6.4.1. A sum of five million (5,000,000) rubles, zero (00) kopeks, including all taxes and fees to the Competition Finalist, is paid to the Winner of the Competition ranked first at the second stage of the Competition and recognized as the Competition Winner by the Jury.

6.4.2. A sum of three million (3,000,000) rubles, zero (00) kopeks, including all taxes and fees applicable to the Finalist, shall be paid to the Finalist ranked second at the second stage of the Competition.

6.4.3. A sum of two million (2,000,000) rubles, zero (00) kopeks, including all taxes and fees applicable to the Finalist, shall be paid to the Finalist ranked third at the second stage of the Competition.

6.5. Based on the contract concluded between the Operator and the Finalist, the Operator shall additionally pay the costs of travel based on the calculation of air travel in economy class and organize accommodation at the venue of the in-person events in accordance with the Competition Roadmap (Appendix 1) for 2 (two) representatives from each Finalist (4\* hotel, duration according to the event program), as well as organize logistics according to the event program.

6.6. If a decision is made to disqualify the Finalist, the Competition Operator has the right to demand the return of monies paid to the Finalist under the Agreement concluded, as well as compensation for the Competition Operator's expenses related to the Finalist's participation in the in-person events of the Competition.
